PROCEEDINGS.

Sub:—Alienation—Land—Chittoor district—Tirupathi (Urban) Revenue Mandal—R.S.No.246, Peddacheruvu of Tirupathi—extent 23.25 acres—alienation in favour of TUDA—Advance possession handing over—Orders—Issued.

ORDER:

The Vice Chairman, Tirupathi Urban Development Authority, Tirupathi has applied for alienation of 22.53 acres of land in S.No.246 of Tirupathi Revenue village for plotted development scheme, shopping complex, parks and primary school. Vice Chairman, TUDA has also requested the District Collector, Chittoor to hand over advance possession of the land measuring 22.53 acres pending finalisation of alienation proposals, so as to enable to formulate a scheme in detail and approach HUDCO for financial assistance.

The Collector, the Joint Collector and the Vice Chairman and Managing Director, TUDA, Tirupathi along with the Revenue Divisional Officer, Tirupathi and the Mandal Revenue Officer, Tirupathi (Urban) have inspected the S.No.246 Peddacheruvu of Tirupathi, Tirupathi (Urban) Mandal on 15-4-1986 and found that the TUDA has formed 80' road from East to West running across the S.No.246 and as a result S.No.246 is divided into 2 blocks. The northern side of the S.No.246 has an extent of 23.25 acres which is required by the TUDA for plotted development scheme.

Sanction is hereby accorded to hand over advance possession of land measuring an extent of 23.25 acres in S.No.246 of Tirupathi of Tirupathi (Urban) Mandal to the Vice Chairman and Managing Director TUDA, Tirupathi, subject to payment of market value as fixed by the Government and pending finalisation of alienation proposals.


The Mandal Revenue Officer, Tirupathi (Urban) is requested to hand over advance possession of an extent of 23.25 acres in S.No.246 of Tirupathi of Tirupathi (Urban) Mandal to the Vice Chairman and Managing Director, TUDA, Tirupathi and report compliance. He is also requested to send a sketch showing the actual area handed over to the Vice Chairman and Managing Director, TUDA, Tirupathi.

The Mandal Revenue Officer, Tirupathi (Urban) is also requested to submit alienation proposals in S.No.246 measuring an extent of 23.25 acres, through the Revenue Divisional Officer, Tirupathi, in full shape in favour of Vice Chairman, & Managing Director, Tirupathi Urban Development Authority, Tirupathi, immediately.
