In the circumstances reported by the Collector, Chittoor and as recommended by the Commissioner of Land Revenue, Hyderabad in the reference 1st and 2nd read above, Government direct that the Government land in sy.No.246/1 to an extent 23.25 acres (twenty three acres twenty five cents only) be allotted in favour of Tirupathi Urban Development Authority for developing the lands under sites and services program on payment of market value @ Rs.50,000/- (Rupees fifty thousand per acre only) per acre in relaxation of ban orders issued in G.O.No.633, Revenue (G) Department dated 5-9-1982, G.O.No.696, Revenue dated 24-6-1985 as amended in G.O.No.911, Revenue (G) Department dated 1-8-1985 and G.O.No.157, Revenue (H) Department dated 13-2-1987.

2. The action of the Collector, Chittoor in handing over advance possession of the land in anticipation of the orders of the Government is hereby ratified.
3. The Collector, Chittoor is requested to take necessary further action.
4. The Record of enquiry received with the reference 1st read above is returned herewith to the Collector, Chittoor and he is requested to acknowledge its receipt by return of post.
